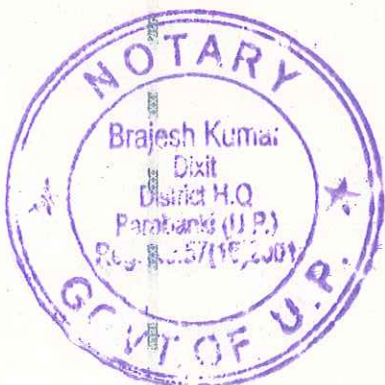

- Any modifications to this MoU must be made in writing and agreed upon by both parties.


## **Termination**


- Either party may terminate the MoU with one month's written notice.





