Hostel Fees (Fees + Caution Money)

Important Note:

1. In case of Lateral Entry admission, Total Fees will be charged as 1st year Fees including Caution Money.
2. In addition to the respective Course Fee, the amount of Rs. 100/- per year will be charged from the students for Students' Welfare Fund excluding Ph.D., M. Tech. (Part Time), LL.M.Courses, which will be exempted from compulsory contribution.
