## Procedure for Scrutiny & Revaluation (Session 2024-25: Odd Semester)

During evaluation and post evaluation, precision and accuracy is ensured at various levels. However if any student is confident of better results/grades after result declaration, he/she may apply for scrutiny and later on revaluation as per laid down policy:

**Scrutiny:** Any student can apply for Scrutiny as per process laid down:

- 1. Any student who has appeared in the End Semester/Annual Examination may apply for Scrutiny on the prescribed format (attached as Appendix A). In the scrutiny of any answer sheet, following will be checked:
  - a) Totaling of marks will be checked
  - b) Evaluation of unevaluated answers
- The scrutiny will be done only for theory paper (s) examination and not for practical subject(s)/courses.
- The students who are intended to apply for scrutiny are required to deposit Rs. 2,000/-3. (Rupees Two Thousand Only) per course in the Accounts Office and required to submit duly filled form along with the fee receipt in the Examination Cell till January 23, 2025.
- A committee for Scrutiny and Revaluation will be constituted including subject expert for the Scrutiny and the result will be notified accordingly tentatively till January 28, 2025. However, revaluation of answer sheets will not be done during scrutiny.

Revaluation: Any student, who is not satisfied with his/her Scrutiny result, may apply for Revaluation (only after Scrutiny) as per laid down process:

- 5. If any student is seeking for revaluation after scrutiny, he/she will be required to fill the prescribed format (attached as Appendix B) within a week after the declaration of scrutiny result along with a submission of Rs. 5,000/- (Rupees Five Thousand Only) per course.
- If any student would like to see his answer sheet also along with the revaluation, he/she will be required to submit Rs. 6,000/- (Rupees Six Thousand Only) per course.
- 7. Scrutiny and Revaluation committee will reevaluate the answer sheets and the result will be notified accordingly within 07 days.
