## **NOTICE - EXAMINATION**

### Procedure for Make-Up Examination (Session 2024-25\_Even Semester)

As per special provision, Make-Up Examination shall be conducted by the Department/Faculty/Institute during April 28-30, 2025 for the students who could not appear in Mid Term or wish to improve their marks secured in Mid-Term Examination. The schedule will be notified by the respective Department/Faculty/Institute. Students are required to refer to the laid down points for appearing in Make-Up Examination:

- 1. If, during the scheduled Mid-Term Examination, any eligible student (who was fulfilling the attendance criteria during the Mid Term) could not appear in the Examination due to any unforeseen situations like a) Marriage of sister/brother, b) Accident/health issue, c) Appearing in any competitive exams of national level, or d) Critical illness/demise of guardian, they will be given the opportunity for appearing in the Make-Up Examination. Students are required to complete the prescribed form (Format 47) and submit all supporting documents to their respective HoDs/Deans/Directors by April 23, 2025 which will be assessed by them till April 24, 2025 for further consideration of higher authorities and subsequent conduction of Make-Up Examination.
- 2. Any student who could not attend the Mid-Term Examination due to insufficient attendance must have maintained a minimum of 50% attendance one week prior to the commencement of the Make-Up Examination (i.e. by April 21, 2025). Eligible students are required to complete the prescribed form (Format 47) and then submitting a fee of Rs. 10,000/- (if they meet the attendance criteria) at the Accounts Office for appearing in the Make-Up Examination. Duly filled format approved by the Course Coordinator along with the fee receipt should be submitted to the respective HODs/Deans/Directors by April 23, 2025 which will be verified by them till April 24, 2025 to facilitate the conduction of Make-Up Examination.
- 3. Any student who wishes to improve his/her marks secured during the Mid-Term Examination, will be required to maintain a minimum of 50% attendance one week prior to the commencement (i.e. by April 21, 2025) for filling the prescribed form (Format 48), then submitting the improvement fee of Rs. 500/- per subject/course of the respective programme in the Accounts Office. The duly filled form along with the fee receipt should be submitted to Course Coordinator by April 23, 2025 for finalizing the list by respective HODs/Deans/Directors till April 24, 2025.
