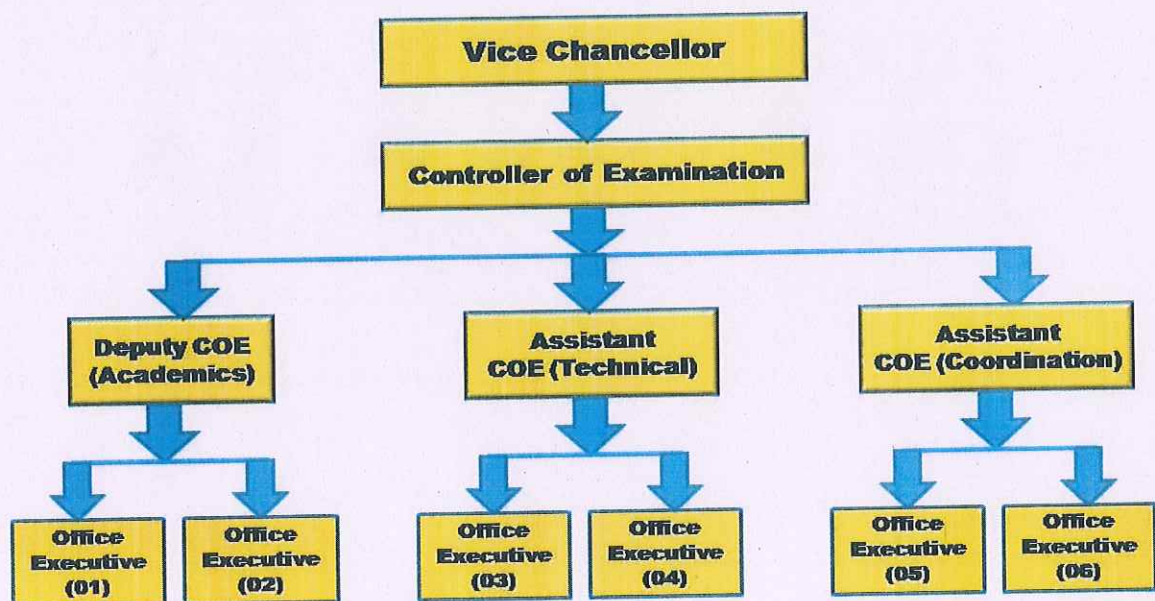
## Annual Report (Session 2020-21)

**Format of Question Papers**

The question papers for the End Semester Examination comprised of questions from entire syllabus as per the weight-age of the modules of the concerned course unit. The questions were framed in a way to assess the Learning Outcomes properly and weight-age given to each module of instruction.

### Setting of Question Papers

Certain important points which were included in the guidelines to ensure the appropriate designing of question paper:

- As per the University Norms & Guidelines, the question paper should be designed in such a way that it segregates outstanding students among the students appearing for the examination and grade them in Outstanding, Excellent, Very Good, average & Pass. Outstanding students should be in the range of 5% of total and unsuccessful category of students should not be more than 10% of students.
- The question paper setter should decide the weight-age of various Chapters and Units of the syllabus and frame the questions accordingly ensuring the coverage of all Chapters and Units. The questions should be evenly distributed from the prescribed syllabus.
- Questions should be based upon course learning outcome as provided in the syllabus and use corresponding cues/verbs of revised Bloom's Taxonomy for examination.
- The language of question should be simple. Ambiguous and confusing terminology should not be used. Construction of simple sentence is desired excluding unnecessary details. Suppose, if short note is desired on any topic, the better way to limit the words i.e. 200 to 250 words to avoid ambiguity.
- The faculty members must ensure insertion of correct answer and re-check while updating it.
- In order to maintain the security, faculty members must ensure resetting of their passwords on portal.
- Difficulty level of each question and entire question paper should be analyzed. Generally, 50% to 60% of student (average) should be able to score average grading in the subject. At least 5% of students should only be able to answer one odd question which has significant difficulty level in comparison to filter outstanding students.
- The questions in a question Paper should be aligned with the respective sections and duration. Indicated time duration in the templates to complete the question paper should be based upon the time taken by an average student.
- The repetitive questions should not be more than 20% in the question paper of the End Semester Examination which has already been asked in the previous test/examination.




To maintain the confidentiality, the whole process of receiving the question paper was done through SRMU Examination Portal. As per the Question Paper Moderation Guidelines, the question papers were moderated centrally in the Examination Cell in the secured manner under the surveillance of CCTV and in the presence of COE and Deputy COE and then finalized papers were utilized for the conduction.

### Moderation of question papers

To ensure consistency of question papers within the framework of the syllabus, thereby ensuring consistency of assessment for all students, moderation of Question Paper is being done as per the Guidelines/Checklist. It also ensures that weightage within a module is appropriate and conforms to the blueprint, thereby ensuring fairness, accuracy and consistency in marking.

The committee ensured following guidelines during moderation:

- The questions are from within the syllabus and framed in a manner intelligible to the student.

- b) The coverage and level of the question paper are appropriate and consistent with the curriculum and assessment framework
- c) The prescribed time duration for Question Paper justify with the framed questions given and marks allocation.
- d) The questions are correctly mapped with the appropriate level of Course Learning Outcome CLO and Bloom's Taxonomy (BL).
- e) The question paper contains no ambiguity and the wording of each question is precise, definite and easily understandable
- f) The layout of the QP is in the approved University format and prescribed template has been used.
- g) The question paper model conforms to the Study and Evaluation Scheme of particular program.
- h) The question papers contain required additional information with reference to the relevant questions (for example, tables, graphs, etc).
- i) The Question Paper has no spelling mistakes or other errors.
- j) The instructions in the Section A, B & C are align with the questions asked in the QP.

*In case suggested changes are more than 25% during the moderation of question paper, then the Question Paper will be changed. Although there was no such change in the Question Paper of the session 2020-21*

As the Moderation Committees' work is secret in nature, adoption of various security measures ensures confidentiality.




#### 6. Attendance Criterion for appearing in Examination

As per the University Ordinance, all students should maintain 100% attendance. However, 75% attendance (Overall) is mandatory to appear in the End Semester Examination with further relaxation upto 15% (i.e. 60% overall) in extraordinary situations including medical or any other things like sports, extra-curricular activities etc with prior permission of competent authority.

But in view of COVID-19 pandemic, subsequent lockdown and online mode of teaching, there was no such attendance criterion for the students to appear in the examination.

## 7. Preparation and Conduction of Examination

### 7.1 Mode of Conduction of Examination

In the phase of transition, the University adopted SRMU-g suite Google Classroom platform for its feasibility of conducting online examination effortlessly not only on computer/laptop but also on the mobile phones for students sitting in remote areas.

This online examination was conducted through Google Platform which was proctored through G-Meet by the faculty members and members of Examination Cell.

As per Examination Policy, Students were permitted to appear in the Carry Over/Special Summer Examination Papers to prepare themselves for further improvement in their Carry Over/Special Summer Examination Papers.

### 7.2 Conduct of Examinations

**In odd Semester, due to COVID-19 pandemic, only online examinations were conducted for all the programs.** As per the Examination Policy in the Even Semester, online proctoring was done by the respective faculty members along with the Examination Cell under the supervision of COE.

**In Even Semester, Due to COVID-19 pandemic, only online examinations were conducted of final year. However as per the guidelines of UP Govt, examination of all years was conducted for the technical programmes.** Online proctoring was done by the respective faculty members along with the Examination Cell under the supervision of COE.

**However, offline examinations were conducted for the Pre Ph.D. Course Work Examination and Special Summer Examination.**

**7.3 Duration of Papers**

**In Odd Semester:** Online examination was conducted for the maximum duration of two hours (2 hours) in two shifts as under:

First Shift: 10:30 AM – 12:30 PM

Second Shift: 02:00 PM – 04:00 PM

**In Even Semester:** As per the guidelines of Technical Education Department, UP, Online examination was conducted for the maximum duration of one and half hour (1.5 hours) in two shifts as under:

First Shift: 10:30 AM – 12:00 Noon

Second Shift: 02:00 PM – 03:30 PM

**7.4 Status of UFM Cases**

As per new Examination Policy due to pandemic, online proctoring was done by the respective faculty members along with the Examination Cell under the supervision of COE. No UFM cases were observed in the Online Examination.

**7.5 Evaluation of Answer Sheets**

After conduction of End Semester Examination of exceptional courses through Google Doc/Google Form, the pdf file/google sheets of each course submitted by the students were downloaded by the assigned Faculty members in one folder for evaluation using paint or any other software. After evaluation, e-folders containing all the documents were created by the assigned faculty members for onwards submission in Examination Cell through their Departments.

Based upon the student performance during Online End Semester Examination (Odd Semester) and internal assessment (Odd Semester), grades were awarded to all the students in the Odd Semester.

In the Even Semester, where only Internal Assessments (Even Semester) were done and End Semester Examinations (Even Semester) were not conducted in the non technical programs as per UP Govt. Guidelines, interpolation was carried out for promotion of students on the basis of guidelines. In the exceptional cases due to some health issues/other reasons, few students who could not appeared in the Odd Semester Examination but appeared in all the internal examinations of Even Semester, their internal marks obtained in even semester were interpolated to avoid any academic loss.

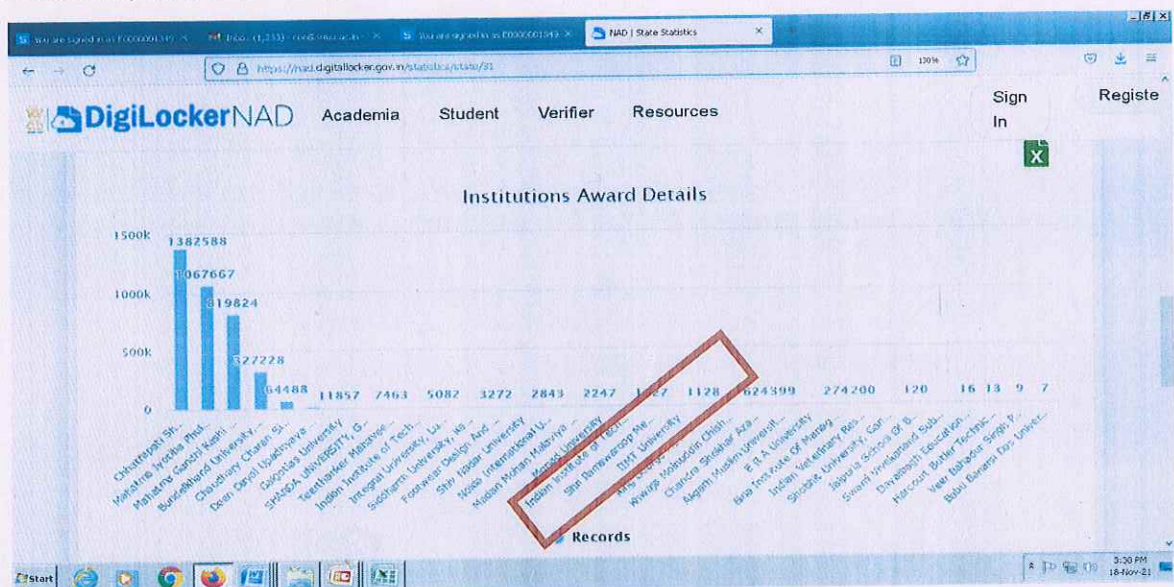


**Declaration of Results:**
